Necessary compliance in reference to the recommendations given below is solicited from the College within next two months.

1. The College has intake capacity of two basic units (100 intake capacity) as per NCTE norms for B.Ed. course. The college has a building for running the course having four classrooms with 50 students sitting capacity. The classrooms are well lighted and ventilated. The curriculum laboratories are equipped with relevant equipment and established in separate rooms and one seminar hall is also available.
2. The college has appointed Principal and teaching staff duly approved by SPU, Mandi. The non-teaching staff is appointed by the management of the college.
3. The salary to teaching and non teaching staff is disbursed through bank.
4. College has adequate infrastructural and instructional facilities. However, common rooms of boys and girls should have attached washrooms.
5. The college building is disabled friendly.
6. Separate toilets for boys and girls are available in the campus.
7. The college has a library and contains total 4250 books and reference books. The college has also subscribed three newspapers and two journals. More titles and reference books should be added in the library.
8. The computer laboratory is equipped with 10 PCs with Jio Air Fiber connectivity and campus having Wi-Fi facility. However, latest configured PC be added in the computer laboratory.
9. The committee also checked the various stock registers and records which have been found satisfactory.
10. The mandatory information (as per letter F.No. NRC/NCTE/CO/website/2021/213986 dated 28th April 2021 of NCTE) related to B.Ed. Course should be updated.

11. College has deposited inspection fees of Rs. 141600/- (Rupees One lakh forty one thousand six hundred only) with GST vide cheque no. 064687 dated 03-05-2024.
12. College has deposited affiliation fee of Rs 136000/- (Rupees One lakh thirty six thousand only) with GST vide cheque no. 064688 dated 03-05-2024.
